Aswesuma Welfare Benefit Payment Scheme published in the *Gazette Notification No. 2328/13* dated April 21, 2023 is hereby rescinded and however, such payments related to Schedule I shall be made up to 31.12.2023 with respect to the beneficiaries whose payments have been delayed due to various reasons and to the applicants who will subsequently be entitled for this scheme upon their eligibility for selection from those who have already forwarded their appeals and investigations are still underway.
